Notice is hereby given that a Bond and Maintenance Tax Election will be held on November 4, 2025, between 7:00 a.m. and 7:00 p.m.

Early voting by personal appearance shall be conducted at the locations and during the hours described on the attached Exhibit "A".

The polling locations on Election Day, November 4, 2025, are attached hereto as Exhibit "B".

The official address of the Early Voting Clerk is 9159 Airport Road, Conroe, Texas 77303. Except as otherwise allowed by law, applications for ballots to be voted by mail shall be mailed to the Early Voting Clerk at such address and marked ballots to be voted by mail shall be returned by mail to such address. Applications for ballots by mail must be received no later than the close of business on October 24, 2025.

ORDER CALLING ROAD AND PARK BOND AND TAX ELECTION

THE STATE OF TEXAS §

MONTGOMERY COUNTY MUNICIPAL UTILITY DISTRICT NO. 209 §

WHEREAS, Montgomery County Municipal Utility District No. 209 (the "District") was heretofore duly created pursuant to House Bill 4641, 87th Texas Legislature, 2021 Regular Session, codified at Chapter 7941A, Texas Special District Local Laws Code, effective June 15, 2021, as a conservation and reclamation district created under and essential to accomplish the purposes of Section 52, Article III, and Section 59, Article XVI, of the Texas Constitution and operating pursuant to Chapters 49 and 54 of the Texas Water Code; and

WHEREAS, the directors of the District, appointed in accordance with the Act, have met and organized and have qualified to serve as directors of the District by taking the oath and making the bond required by law; and

WHEREAS, it is now timely to call an election to authorize the Board of Directors to issue bonds of the District to provide roads for the District; and

WHEREAS, it is now timely to call an election to authorize the Board of Directors to issue bonds of the District to provide park and recreational facilities for the District; and

WHEREAS, there has been filed with the District, open to inspection by the public, an engineering report for the roads and park and recreational facilities from Robert Deden Services, Inc., covering the works, improvements, facilities, capacities, plants, equipment and appliances to be purchased, constructed or otherwise acquired by the District and the property, contract rights, rights of use and interests in property to be purchased or otherwise acquired, as well as the estimated cost of all the foregoing, together with maps, plats, profiles and data showing and explaining the report (the "Engineering Report"), and the Engineering Report has been carefully considered by the Board and has been fully approved by the Board; and

WHEREAS, the Engineering Report heretofore filed and approved contains an estimate of the cost of the purchase, construction or other acquisition of the proposed works, improvements, facilities, capacities, plants, equipment and appliances, an estimate of the cost of purchase or other acquisition of property, contract rights, rights of use and interests in property, and an estimate of expenses incident thereto; and

WHEREAS, as required by Section 49.4645(b), Texas Water Code, there has been filed in the office of the District for review by the public a park plan covering the improvements, facilities, and equipment to be purchased or constructed and their estimated cost, together with maps, plats, drawings, and data fully showing and explaining the park plan (the "Park Plan"); and

WHEREAS, in accordance with Section 49.465, Texas Water Code, the Board finds that the size and location of the recreational facilities described in the Park Plan have been established in consideration

of municipal or county recreational facilities, whether existing or proposed, if any, that serve or will serve the area in which the District is located; and

WHEREAS, the Board finds that the estimates of (i) \$11,128,000 in bonds for road purposes, (ii) \$11,128,000 in bonds for road refunding purposes, (iii) \$9,748,000 in bonds for parks and recreational facilities purposes, and (iv) \$9,748,000 in bonds for parks and recreational refunding purposes are reasonable and proper and hereby approve the same and all items thereof but reserves the right to authorize amendment to the engineering report and to reallocate costs and make such other changes as necessary to meet the changing requirements of the District's system; and

WHEREAS, the Board is of the opinion that it would be of benefit to the District to be authorized to levy and collect annual ad valorem taxes at a rate not to exceed \$1.50 per \$100.00 of assessed valuation on all taxable property within the District to secure funds for road maintenance purposes; and

WHEREAS, the Board is of the opinion that it would be of benefit to the District to be authorized to levy and collect annual ad valorem taxes at a rate not to exceed \$0.10 per \$100.00 of assessed valuation on all taxable property within the District to secure funds for park and recreational facility maintenance purposes; and

WHEREAS, all of the bonds which may be issued from each proposition will be secured by the levy of an ad valorem tax unlimited as to rate or amount; and

WHEREAS, the estimated ad valorem tax rate necessary to support the bonds authorized hereunder is \$1.25 per \$100 of assessed valuation on all taxable property within the District; and

WHEREAS, under current law and the bond proposition the maximum rate of interest any issue of the proposed bonds may bear is fifteen per cent (15%) per annum; and

WHEREAS, under current law and the bond proposition, the maximum term of any series of bonds shall not exceed forty (40) years; and

WHEREAS, under current law the District cannot issue general obligation bonds with a weighted average maturity of the issue of bonds exceeding 120 percent of the reasonable expected weighted average economic life of the improvements with the issue of bonds; and

WHEREAS, at the commencement of the District's current fiscal year, the District has authorized the sale of bonds, therefore the District's aggregate bonded debt outstanding is \$-0- and the aggregate outstanding amount of interest on debt obligations of the District is \$-0-. Further, the District has not yet levied a road maintenance tax, or a park and recreational facilities maintenance tax; and

WHEREAS, the Board of Directors is of the opinion that an election should be held on November 4, 2025, for the purposes of:

- A. submitting a proposition on the issuance of the District's bonds in the maximum aggregate original principal amount of \$11,128,000 to develop and finance macadamized, graveled, or paved roads or improvements, including storm drainage in aid of those roads;
- B. submitting a proposition on the issuance of the District's bonds in the maximum aggregate original principal amount of \$11,128,000 to refund bonds issued to develop

and finance macadamized, graveled, or paved roads or improvements, including storm drainage in aid of those roads;

- C. submitting a proposition on the issuance of bonds in the maximum aggregate original principal amount of \$9,748,000 to develop parks and recreational facilities;
- D. submitting a proposition on the issuance of the District's bonds in the maximum aggregate original principal amount of \$9,748,000 to refund bonds issued to develop parks and recreational facilities;
- E. submitting a proposition on the levying and collecting of an annual ad valorem tax not to exceed \$1.50 per \$100 per assessed valuation for road maintenance and operation purposes;
- F. submitting a proposition on the levying and collecting of an annual ad valorem tax not to exceed \$0.10 per \$100 assessed valuation for park and recreational facility operation and maintenance purposes; and

WHEREAS, the Board of Directors wishes to proceed with the ordering of said election.

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF MONTGOMERY COUNTY MUNICIPAL UTILITY DISTRICT NO. 209:

Section 1: The matters and facts set out in the preamble of this order are hereby found and declared to be true and complete.

Section 2: The Engineering Report and estimate of costs hereinabove mentioned are hereby approved.

Section 3: The Park Plan and estimate of costs above are hereby approved.

Section 4: An election shall be held on Tuesday, November 4, 2025, between the hours of 7:00 a.m. and 7:00 p.m., at polling locations designated for Montgomery County, Texas, places which the Board of Directors of the District, after duly considering the requirements of the Texas Election Code, finds to be proper places for conducting said election, at which the following propositions shall be submitted:

PROPOSITION A

THIS IS A TAX INCREASE. Shall the Board of Directors of Montgomery County Municipal Utility District No. 209 be authorized to issue bonds of said district in one or more issues or series in the maximum principal amount of \$11,128,000 maturing serially or otherwise in such installments as are fixed by said Board of Directors over a period or periods not exceeding forty (40) years from their date or dates, bearing interest at any rate or rates, and to sell said bonds at any price or prices, provided that the net effective interest rate, as defined by Chapter 1204, Texas Government Code, as amended, on any issue or series of said bonds shall not exceed the maximum legal limit in effect at the time of issuance of each such issue or series, all as may be determined by the Board of Directors of said district, for the purpose or purposes of designing, purchasing, constructing, acquiring, improving, financing, owning, operating or maintaining macadamized, graveled, or paved roads and turnpikes, for said district and additions,

extensions and improvements thereto, including storm drainage, in aid of those roads and turnpikes, and purchasing or otherwise acquiring any and all property, contract rights, rights of use and interests in property necessary, appropriate or incident to the purchase, construction, acquisition, improvement, ownership, operation or maintenance of such macadamized, graveled, or paved roads and turnpikes, and additions, extensions and improvements thereto, including storm drainage, in aid of those roads and turnpikes, and for the additional purpose of paying all expenses in any manner incidental thereto which under applicable law may properly be paid from the proceeds of such bonds; and to provide for the payment of principal of and interest on such bonds by the levy and collection of a sufficient tax, without limit as to rate or amount, upon all taxable property within said district, all as authorized by the constitution and laws of the State of Texas, including particularly (but not by way of limitation) Article III, Section 52(b)(3) of the Texas Constitution, and Chapters 49 and 54 of the Texas Water Code, to the extent applicable, together with all amendments and additions thereto?

PROPOSITION B

THIS IS A TAX INCREASE. Shall the Board of Directors of Montgomery County Municipal Utility District No. 209 be authorized to issue bonds of said district in one or more issues or series in the maximum principal amount of \$11,128,000 maturing serially or otherwise in such installments as are fixed by said Board of Directors over a period or periods not exceeding forty (40) years from their date or dates, bearing interest at any rate or rates, and to sell said bonds at any price or prices, provided that the net effective interest rate, as defined by Chapter 1204, Texas Government Code, as amended, on any issue or series of said bonds shall not exceed the maximum legal limit in effect at the time of issuance of each such issue or series, all as may be determined by the Board of Directors of said district, for the purpose or purposes of refunding by any means now or hereafter authorized by law, all or any portion of said bonds of the district issued for the purpose or purposes of designing, purchasing, constructing, acquiring, improving, financing, owning, operating or maintaining macadamized, graveled, or paved roads and turnpikes for said district and additions, extensions and improvements thereto, including storm drainage, in aid of those roads and turnpikes, and purchasing or otherwise acquiring any and all property, contract rights, rights of use and interests in property necessary, appropriate or incident to the purchase, construction, acquisition, improvement, ownership, operation or maintenance of such macadamized, graveled or paved roads and turnpikes, for said district and additions, extensions and improvements thereto, including storm drainage, in aid of those roads and turnpikes, and refunding such bonds, and for the additional purpose of paying all expenses in any manner incidental thereto which under applicable law may properly be paid from the proceeds of such refunding bonds, whether heretofore, hereunder or hereafter authorized or issued by the district; and to provide for the payment of principal of and interest on such bonds by the levy and collection of a sufficient tax, without limit as to rate or amount, upon all taxable property within said district, all as authorized by the constitution and laws of the State of Texas, including particularly (but not by way of limitation) Article III, Section 52 of the Texas Constitution, Chapter 1207 of the Texas Government Code, and Chapters 49 and 54 of the Texas Water Code, to the extent applicable, together with all amendments and additions thereto?

PROPOSITION C

THIS IS A TAX INCREASE. Shall the Board of Directors of Montgomery County Municipal Utility District No. 209 be authorized to issue bonds of said district in one or more issues or series in the maximum principal amount of \$9,748,000 maturing serially or otherwise in such installments as are fixed by said Board of Directors over a period or periods not exceeding forty (40) years from their date or dates, bearing interest at any rate or rates and to sell said bonds at any price or prices, provided that the net effective interest rate, as defined by Chapter 1204, Texas Government Code, as amended, on any issue or series of said bonds shall not exceed the maximum legal limit in effect at the time of issuance of each such issue or series, all as may be determined by the Board of Directors of said district, for the purpose or purposes of acquiring, purchasing, owning, operating, repairing or improving parks, landscaping, parkways, greenbelts, sidewalks, trails, public right-of-way beautification projects and recreational equipment and facilities and associated street and security lighting, including, but not limited to, all additions to the parks and recreational facilities and all works, improvements, facilities, equipment, appliances, interests in property, and contract rights needed therefor, and for the purpose of paying all expenses in any manner incidental thereto which under applicable law may properly be paid from the proceeds of such bonds; and to provide for the payment of principal of and interest on such bonds by the levy and collection of a sufficient tax, without limit as to rate or amount, upon all taxable property within said district, all as authorized by the constitution and laws of the State of Texas, including particularly (but not by way of limitation) Article XVI, Section 59 of the Texas Constitution, Chapters 49 and 54 of the Texas Water Code, to the extent applicable, together with all amendments and additions thereto?

PROPOSITION D

THIS IS A TAX INCREASE. 1207 of the Texas Government Code and Chapters 49 and 54 of the Texas Water Code, to the extent applicable, together with all amendments and additions thereto?

Section 6: In accordance with Texas Election Code, Section 3.009, the District currently estimates that, if the proposition contained herein were approved and the bonds proposed herein were authorized and issued, the District's ad valorem debt service tax rate is projected to be a maximum of approximately \$1.25 per \$100 of assessed valuation. The estimated tax rate is based on current assumptions and projections of interest rates, property development, assessed valuations and tax collection rates. To the extent that such assumptions and projects are not realized, the actual tax rate assessed by the District may vary substantially from the estimated tax rate. The estimated tax rate provided in this Section shall not be considered part of the bond propositions submitted to the voters pursuant to this Order and shall not be considered as a limitation on the District's authority to levy, assess and collect an unlimited tax as to rate or amount pursuant to Texas Constitution Article XVI, Section 59.

Section 7: In accordance with Section 1253.002, Texas Government Code, the District will not issue any general obligation bonds authorized herein with a weighted average maturity exceeding 120 percent of the reasonably expected weighted average economic life of the improvements financed with the issue of bonds.

Section 8: Montgomery County (the "County") shall designate the election precinct(s). The County shall appoint election officers as required by law and provided under the District's contract with the County to conduct the election.

Early voting in the election by personal appearance shall begin on October 20, 2025, and shall continue through October 31, 2025. Early voting in the election shall be conducted under contract with Montgomery County at the locations and during the hours designated by the County. The clerk for early voting shall be the Montgomery County Early Voting Clerk.

Section 9: The election shall be held and conducted and returns made to this Board of Directors in accordance with the Texas Election Code as modified by Chapter 49, Texas Water Code.

Section 10: The Board of Directors of the District hereby appoints Coats Rose, P.C., as the District agent for the election.

Section 11: All qualified resident electors of the District shall be entitled to vote in the election.

Section 12: The President and the Secretary of the Board or the District's agent is hereby directed to cause notice of this election to be posted (i) on election day and during early voting by personal appearance, in a prominent location at each polling place, (ii) in three public places in the boundaries of the political subdivision at least 21 days before the election, (iii) during the 21 days before the election shall be posted on the political subdivision's website, prominently and together with the notice of election, the contents of the proposition, and any sample ballot prepared for the election, if the District maintains an internet website, and (iv) at such other places as notice of the meetings of the Board of Directors of the District are required to be posted.

Additionally, the President and the Secretary of the Board or the District's agent is hereby directed to prepare voter information documents in accordance with Section 1251.052(b) of the Texas Government Code and to cause such documents to be posted in the same manner as this Order as described above.

Section 13: If applicable, the rate of pay for judges and clerks of the election shall be determined by the Board of Directors of the District, in compliance with the Texas Election Code.

Section 14: The President or Vice President and Secretary or Assistant Secretary are authorized and directed to take any action necessary to carry out the provisions of this order.

Sección 12: Por la presente, se instruye al Presidente y al Secretario de la Junta o al agente del Distrito a que hagan colocar una copia de esta Orden (i) el día de elección y durante el periodo de votación anticipada en persona en un lugar destacado en cada lugar de votación, (ii) en tres lugares públicos dentro de los límites de la subdivisión política al menos 21 días antes de la elección, y (iii) durante los 21 días previos a la elección se colocará en el sitio web de la subdivisión política, de una manera destacada y junto con el aviso de elección, el contenido de la proposición y cualquier boleta de muestra preparada para la elección, si el Distrito mantiene un sitio web, y (iv) en ciertos otros lugares en los que se requiere que los avisos de asamblea de la Junta Directiva del Distrito sean colocados.

Sección 13: Según corresponda, la tarifa del pago de los jueces y de los funcionarios de la elección será determinada por la Junta Directiva del Distrito, en conformidad con el Código Electoral de Texas.

Sección 14: Se autoriza e instruye al Presidente o al Vicepresidente y al Secretario o al Secretario Asistente a tomar cualquier medida necesaria para llevar a cabo las disposiciones de esta orden.
