ORDER CALLING BOND ELECTION

At a meeting of the Board of Directors (the “Board”) of PORTER MUNICIPAL UTILITY DISTRICT held on August 15, 2023, at which was present a quorum of directors of said Board, as follows:

It was duly moved, seconded and unanimously carried that the order set out below be passed and adopted, all directors present voting “aye” and no one voting “no.” Said order is as follows:

WHEREAS, PORTER MUNICIPAL UTILITY DISTRICT, of Montgomery County, Texas, (the “District”) has been legally created; and the directors of the District have qualified as required by law, met and organized; and the District is authorized to issue bonds supported by ad valorem taxes to pay for the development and maintenance of a water supply and distribution system, sanitary sewer system, and drainage and storm sewer system facilities, provided that the bonds are authorized by the qualified voters of the District voting in an election held for that purpose.

WHEREAS, as required by Section 49.106, Texas Water Code, there has been filed in the office of the District open to inspection by the public, an engineer’s report, and any supplemental letters or amendments, covering the land, improvements, facilities, plants, equipment, and appliances to be purchased or constructed and their estimated cost, together with maps, plats, drawings and data fully showing and explaining the report (the “Engineering Report”), and the Engineering Report has been carefully considered and approved by the Board; and

WHEREAS, the Board finds that the estimate of probable costs of the design, construction, purchase, and acquisition of a water supply and distribution system, sanitary sewer system, and drainage and storm sewer system facilities and additions thereto, and incidental expenses connected with such improvements and the issuance of bonds, contained in the Engineering Report of \$85,500,000, is reasonable and proper and hereby approves the same; and

WHEREAS, the Board desires to call an election for the purpose of submitting a proposition on the issuance of the bonds of the District in the maximum aggregate original principal amount of \$85,500,000, and the levy of taxes in payment of such bonds; and

WHEREAS, the Board of Directors finds and determines that all requirements have been met prerequisite to the ordering of a bond election; and the Board is of the opinion that an election should be held for the purpose of submitting the proposition hereinafter set forth; and

WHEREAS, the Board has the authority to call a bond election for November 7, 2023, and wishes to proceed with the ordering of said election; and

WHEREAS, the Board anticipates that it will enter into an agreement for a joint election pursuant to Chapters 31 and 271, Texas Election Code, with Montgomery County, Texas (the “County”), under the terms of which Suzie Harvey (the “Administrator”), Elections Administrator of Montgomery County, Texas, will provide election administration services on behalf of the District in connection with a joint election to be conducted with the County;

IT IS, THEREFORE, ORDERED BT THE BOARD OF DIRECTORS OF PORTER MUNICIPAL UTILITY DISTRICT THAT:

Section 1: Recitals. All of the matters and facts contained in the “WHEREAS” clauses above are declared to be true and correct.

Section 2. Call of Election; Eligible Electors; Election Day Voting. An election (the “Election”) shall be held on Tuesday, November 7, 2023 (“Election Day”), within the entire territory of the District at which election the proposition contained in Section 9 below shall be submitted. All resident, qualified electors of the District, shall be entitled to vote in the Election. Voting on Election Day will be conducted between 7:00 a.m. and 7:00 p.m. in accordance with Section 271.003, Texas Election Code, at the Election Day polling locations designated for the Election by the County, which locations for purposes of the Election are declared to be public places.

Section 3. Conduct of Election. The Election shall be conducted by election officers, in accordance with the Texas Election Code, Chapters 49 and 54 of the Texas Water Code, and the Constitution and laws of the State of Texas and the United States of America. The Board anticipates that the Election will be conducted under the terms and conditions of a Joint Election Agreement (the “Joint Election Agreement”) pursuant to Chapters 31 and 271 of the Texas Election Code.

Section 4. Applications for Ballots by Mail. Applications for ballot by mail may be submitted by mail, email, or fax, addressed to Suzie Harvey, Montgomery County Elections Administrator and Early Voting Clerk, as follows:

Section 5. Early Voting. Pursuant to Chapter 31 of the Texas Election Code and the Joint Election Agreement, the Board appoints the Administrator as the District's Early Voting Clerk for the Election. Early voting by personal appearance shall be conducted during the hours, on the dates, and at the locations listed on Attachment "A" attached hereto and made a part hereof for all purposes, which locations for purposes of the Election are declared to be public places. Attachment "A" shall be revised and finalized, if necessary, as directed by the Administrator. The Main Early Voting Polling Place will be Central Library, Large Meeting Room, 104 I-45 North, Conroe, Texas 77301. The Administrator's office shall also remain open on Election Day during the hours the polls are required to be open for voting by the Texas Election Code.

Section 6. Voting Precincts. Except as otherwise provided herein, the presently existing boundaries and territory of the respective Montgomery County Election Precincts, to the extent that they are wholly or partially within the territorial boundaries of the District, are hereby designated as the voting precincts of the District for the Election. The precinct number for the District's election precincts shall be the corresponding Montgomery County Election Precinct Number of each precinct that is wholly or partially within the District.

Section 7. Appointment of Agents. To the extent not otherwise provided for in the Joint Election Agreement, the Board appoints the attorneys for the District, Young & Brooks, Houston, Texas (the "Agents"), as agents to the Board Secretary to perform the duties related to the conduct of the Election pursuant to Texas Election Code Section 31.123 and Texas Water Code Section 49.109. The Agents shall maintain an office open for election duties for at least three hours each day, during regular office hours, on regular business days during the period required by law. The Agents shall maintain in their office, the documents, records and other items relating to the election and shall be the persons designated to receive documents on behalf of the District that are required by the Texas Election Code.

Section 8. Cancellation of Joint Election Agreement. Notwithstanding any other language herein to the contrary, if the County for any reason does not conduct a joint election on November 7, 2023, then and only in that event (i) the Joint Election Agreement shall be canceled, (ii) the entire District is declared one precinct for purposes of the Election, (iii) the Election shall be held within the District at polling places to be designated by the board, (iv) the board hereby finds and determines that there are not fewer than 1,000 registered voters resident within the District, and accordingly the designated early voting clerk shall keep said early voting polling place open for early voting by personal appearance for nine hours on each day which is not a Saturday, a Sunday, or an official state holiday, beginning on the 17th day before the Election (or if the 17th day before the Election falls on a Saturday, Sunday, or legal state or national holiday, then beginning on the first business day thereafter) and continuing through the 4th day before the Election, and (v) the Board shall appoint qualified persons as officers of said election and to serve as the early voting ballot board for the Election.

Section 9. Propositions. At the Election the following Proposition, setting forth the purposes for which the bonds shall be authorized, shall be submitted in accordance with law:

PORTER MUNICIPAL UTILITY DISTRICT
PROPOSITION A

Shall the Board of Directors of PORTER MUNICIPAL UTILITY DISTRICT be authorized to issue bonds of said District in the maximum amount of EIGHTY-FIVE MILLION FIVE HUNDRED THOUSAND DOLLARS (\$85,500,000), in one or more issues or series to mature serially or otherwise over a period not to exceed forty (40) years from their date or dates, and to be issued and sold at any price or prices and to bear interest at any rate or rates as shall be determined within the discretion of the Board of Directors of the District at the time of issuance as authorized by law as now enacted or hereafter amended, for the purposes of constructing, acquiring, improving and extending, reimbursing for the costs of constructing, acquiring, improving and extending, owning, operating, maintaining, repairing, contracting for, or making capital contributions for, a water supply and distribution system, a sanitary sewer system, and a drainage and storm sewer system, both within and outside the boundaries of the District, including but not limited to all costs associated with flood plain and wetlands regulation (including mitigation) and endangered species and stormwater permits (including mitigation) and all additions to such systems and all works, improvements, facilities, equipment, appliances, interests in property, and contract rights needed therefor and administrative facilities needed in connection therewith, and making payments under contracts including but not limited to contracts pursuant to Section 49.213 of the Texas Water Code, or in aid of such purposes, redeeming bond anticipation notes issued for such purposes, and paying such expenses as are incidental to the organization, administration and financing of the District, which under applicable law may properly be paid from the proceeds of such bonds, and to provide for the payment of principal of and interest on such bonds by the levy and collection of a sufficient ad valorem tax upon all taxable property within the District, as authorized by the Constitution and laws of the State of Texas?

Section 10: Ballots. The official ballots for the election shall be prepared in accordance with the Texas Election Code so as to permit the electors to vote “FOR” or “AGAINST” the aforesaid Propositions with the ballots to contain such provisions, markings and language as required by law, and with such Proposition to be expressed substantially as follows in English and Spanish:

Each voter shall vote on the proposition by placing an "X" in the square beside the statement indicating the way he or she wishes to vote.

Section 11: Election Code Section 3.009. In accordance with the provisions of Section 3.009(b), Texas Election Code, it is hereby found and determined that:

- a. The proposition language that will appear on the ballot, the purposes for which the bonds are to be authorized, and the principal amount of the bonds to be authorized, are set forth in this Order.
- b. If the bonds are authorized, taxes sufficient to pay the annual principal of and interest on the bonds may be imposed, without limit as to rate or amount.
- c. Based upon the bond market conditions at the date of adoption of this Order, the maximum interest rate for the bonds or any series of the bonds is estimated to be 4.23% as calculated in accordance with applicable law. Such estimate is based on applicable city consent ordinances which currently limit the net effective interest rate of the District's bonds to not more than two percentage points in excess of the highest rate reported by the Daily Bond Buyer in its weekly "20 Bond Index" during the 30-day period next preceding the date notice of sale of such bonds is first published, and on various assumptions relating to factors that contribute to the interest rates on the District's bonds, including current market interest rates, current taxable values and historical growth in taxable values for the District, assumed credit ratings for the proposed bonds, and the issuance schedule and maturity schedule for the bonds. The estimated maximum interest rate is provided for informational purposes only in accordance with Section 3.009(b)(5) of the Texas Election Code and could be affected by material changes in the assumptions used, including future economic and legal changes that are beyond the control of the District. The estimated maximum interest rate provided herein is not a limitation on the interest rate at which the District may request approval of the Texas Commission on Environmental Quality or any successor agency to issue the bonds, or any series thereof, or the interest rate at which the bonds, or any series thereof, may be sold. Such estimate does not create a contract with the voters, does not supersede or amend the proposition(s) to be presented, and is not part of the proposition(s) to be voted on.

- d. The bonds may be issued to mature over a specified number of years not to exceed the maximum number of years authorized by law.
- e. The aggregate amount of the outstanding principal of the District's debt obligations as of the date of this Order is \$47,265,000 and the aggregate amount of the outstanding interest on debt obligations of the District as of the date of this Order is \$35,159,100.
- f. The current ad valorem debt service tax rate of the District is \$0.235 per \$100 valuation of taxable value.

Section 12: Voter Information Document. In accordance with the provisions of Section 1251.052, Texas Government Code, the Voter Information Document for Proposition A set forth in Section 9 hereof is attached hereto as Exhibit "A".

Section 13: Posting of Order and Voter Information Document. The Secretary of the Board of Directors is hereby directed to cause a copy of this Order, including the attached Voter Information Document, to be posted in English and Spanish (i) on Election Day and during early voting by personal appearance, in a prominent location at each polling place; and (ii) not later than the 21st day before Election Day, in three public places in the boundaries of the District; and (iii) during the 21 days before the Election, on the District's Internet website, prominently and together with notice of the Election, the contents of the propositions, and any sample ballot prepared for the Election.

Section 14: Notice of Election. The Secretary of the Board of Directors is hereby directed to cause notice of the Election, in English and Spanish, to be (i) given by either publication or posting within the District as provided by law, and (ii) on the internet website maintained by Montgomery County, Texas, the sole county that includes the jurisdiction of the District.

Section 15. Authorization to Execute. The President or Vice-President of the Board is authorized to execute and the Secretary or Assistant Secretary of the Board is authorized to attest this Order on behalf of the Board; and the President or Vice-President of the Board is authorized to do all other things legal and necessary in connection with the holding and consummation of the Election. The Board finds that notice of the date, place and subject of this meeting was posted in accordance with the terms and provisions of the Texas Open Meeting Act at least 72 hours preceding the scheduled time of this meeting.

Section 16. Effective Date. This Order is effective immediately upon its passage and approval.

(1) Assumes an interest rate of 4.23% on the Proposed Bonds and issuance in accordance with the assumed amortization schedule described below. The estimated interest and amortization schedule are based upon current assumptions and projections of interest rates, property development, assessed valuations and tax collection rates. To the extent that such assumptions and projects are not realized, the actual interest on the bonds may vary substantially from the estimated interest presented herein. The estimated interest provided herein shall not be considered part of the bond propositions to be submitted to the voters and shall not be considered as a limitation on the District's authority to levy,

assess and collect an unlimited tax as to rate or amount pursuant to the Texas Constitution and laws.

- (2) Aggregate of all outstanding obligations of the District secured by and payable from ad valorem taxes as of August 15, 2023.

Estimated Annual Increase in Taxes:

The estimated maximum annual increase in the amount of taxes that would be imposed on a residence homestead in the political subdivision with an appraised value of \$100,000 to repay the debt obligations to be authorized under Proposition A, if approved, based upon assumptions made by the governing body of the District, is \$0.

Major Assumptions:

The foregoing information is based upon the following assumptions made by the District's Board of Directors: 1) issuance of the proposed bonds with an amortization schedule that, when combined with the District's current debt service requirements, will produce relatively consistent combined annual debt service requirements over the life of the proposed bonds; 2) assumed growth in assessed valuation of the District of 14.95% per year until 2028 and 3) an assumed interest rate on the proposed bonds of 4.23%.

The information provided in this Document is to comply with Section 1251.052, Texas Government Code, which requires a voter information document for each proposition to be submitted to the voters.

Se presentó debidamente, secundó y aprobó por unanimidad que se aceptara y adoptara la orden descrita más adelante, con la votación de todos los directores presentes “a favor” y ninguno “en contra”. Dicha orden es la siguiente:

EN VISTA DE QUE el DISTRITO DE SERVICIOS PÚBLICOS MUNICIPALES DE PORTER del Condado de Montgomery, Texas, (el “Distrito”) ha sido legalmente creado; y los directores del Distrito cumplen con los requisitos exigidos por ley, se han reunido y organizado; y el Distrito está autorizado para emitir bonos respaldados por impuestos ad valorem para pagar por el desarrollo y el mantenimiento de instalaciones de un sistema de abastecimiento y distribución de agua, sistema de alcantarillado sanitario y sistema de alcantarillado de drenaje y agua de tormenta, siempre que los bonos sean autorizados por los votantes habilitados del Distrito que votan en una elección celebrada con ese propósito.

EN VISTA DE QUE la Junta determina que el estimado de los costos probables de diseño, construcción, compra y adquisición de las instalaciones de un sistema de abastecimiento y distribución de agua, un sistema de alcantarillado sanitario y un sistema de alcantarillado de drenaje y agua de tormenta y sus ampliaciones, y de los gastos incidentales relacionados con dichas mejoras

y con la emisión de bonos, de \$85,500,000 incluido en el Informe de Ingeniería es razonable y adecuado y, por la presente, lo aprueba; y

EN VISTA DE QUE la Junta desea convocar una elección para el propósito de presentar una proposición sobre la emisión de los bonos del Distrito por la cantidad original máxima total de capital de \$85,500,000 y la imposición de impuestos para el pago de dichos bonos; y

Sección 2. Convocatoria de la Elección; Votantes elegibles; Votación el Día de Elección. Se celebrará una elección (la “Elección”) el martes 7 de noviembre de 2023 (“Día de la Elección”) dentro de todo el territorio del Distrito, en la que se presentará la proposición incluida más adelante en la Sección 9. Todos los votantes habilitados residentes del Distrito tendrán derecho a votar en la Elección. Sección 5. Votación anticipada. Conforme al capítulo 31 del Código Electoral de Texas y al Convenio de Elección Conjunta, la Junta designa a la Administradora como 'Oficial de Votación Anticipada del Distrito para la Elección. La votación anticipada en persona se llevará a cabo de acuerdo durante los horarios, fechas y en las ubicaciones indicadas en el Anexo "A" adjunto al presente, que se han incorporado al presente para todos los propósitos, lugares que, a efectos de esta Elección, se declaran lugares públicos. El Anexo "A" será revisado y finalizado, de ser necesario, según lo indique el Administrador. El principal lugar de votación anticipada será en la Sala grande de asambleas de la Biblioteca Central ubicada en 104 I-45 North, Conroe, Texas 77301.
